**REGULATIONS
CONCERNING PRACTICE-ORIENTED STATE EXAM ON HYGIENE, SOCIAL
MEDICINE, ORGANIZATION AND ECONOMY OF PUBLIC HEALTH**

Generalities

Practice-oriented state exam on hygiene, social medicine, organization and economy of public health is held according to the schedule of the educational department of O.O. Bogomolets National Medical University of Ministry of Public Health of Ukraine.

Practice-oriented state exam is the second stage of the governmental certification for medical faculties, which is held in accordance to the Order # 53, 31.01.2005 of Ministry of Public Health of Ukraine “On approval of regulations concerning organization and procedure of governmental attestation of students who graduated from medical schools of III-IV accreditation levels, branch “Medicine”. This stage of attestation is held after receiving the results of the licensed integrated test “Step-2” from the Test Centre.

Students, who meet all requirements of syllabus and program for the speciality, regardless of the results of the licensed integrated test “Step-2” are allowed to pass the practice-oriented state exam.

State board of examiners (SBE) and its secretary is organized one month before the practice-oriented state exam in accordance to the Order of Rector.

Structure of practice-oriented state exam

Practice-oriented state exam on hygiene, social medicine, organization and economy of public health consists on two following parts.

First part of the exam on hygienic subjects consists in solving of typical cases. The results of this task, which is based on the impact of the environmental factors on the population health, allow to assess the graduating student’s practical skills and knowledge concerning planning, carrying out preventive, sanitary and hygienic, anti-epidemic measures, filling of the medical documents.

First part of the exam on social hygiene, organization and economy of public health includes application of methods, which are based on the analysis of quality and quantity of medical service, for determination and assessment of population health in connection with the environmental factors which may impact it for improvement of medical service for the population.

Second part of the exam on hygienic subjects includes the solving of typical cases, which helps to assess the graduating student's practical skills concerning analysis of the hygienic-laboratory research, carrying out of epidemiological analysis, fulfilling the medical documents.

practical and theoretical skills assess by next point:

«1,0» – Done

«,05» – Done with little mistake

«0» – Done with big mistake, Not done

Points are registered by the examiners and members of the SBE in the Protocol for assessment of the first and second part of the exam. The form of the Protocol is specified by the Order # 53 (31.01.05).

Criteria for assessment of result of practice-oriented state exam

Results of the practice-oriented state exam are marked with the following:

- points (maximum – 200)
- traditional marks 5 – „excellent”, 4 – „good”, 3 – „satisfactory”, 2 – „unsatisfactory”.
- ECTS marks – (“A”, “B”, “C”, “D”, “E”, “FX”)

Points, which are fixed in the Individual Protocol of the Exam, are converted into marks.

Criteria for the points and marks:

- 200-180 point –“5”, A
- 179-160 point –“4”, B
- 159-140 point –“4”, C
- 139-120 point –“3”, D
- 119-110 point –“3”, E
- less than 100 –“2”, EF
